NOTICE OF RACE

1 RULES

- 1.1 *The regatta will be governed by the rules as defined in The Racing Rules of Sailing.*
- 1.2 *The Yachting New Zealand Safety Regulations Part 1, shall apply.*

2 ELIGIBILITY AND ENTRY

- 2.1 *The regatta is open to single handed Fibreglass sailing dinghies with a LOA 4.2m / LWL 3.81m / Beam 1.39m - Just like a **Laser**[®].*
- 2.2 *Entry preferred by email by 30/11/2017 on attached entry form.*
- 2.3 *To be eligible to compete in this event each competitor shall be a financial member of a club recognised by the competitor's national authority.*

3 FEES

- 3.1 *Entry fee will be \$20.*

4 SCHEDULE

- 4.1 *Registration: Sat 2/12/17 From 10 am To 1 pm*
- 4.2 *There may be free practise races on Saturday morning.*
- 4.3 *Briefing will be at 1 PM 2/12/17 in the club rooms.*
- 4.4 *Number of races: Multiple races as weather dictates.*
- 4.5 *The scheduled time of the warning signal for the first race is 2 pm Saturday 2/12/17.*
- 4.6 *On Sunday 3/12/17, no warning signal will be made after 2 pm.*

5 SAILING INSTRUCTIONS

5.1 *The sailing instructions will be available to paid up entrants at registration.*

6 VENUE

6.1 *Lake Dunstan Boat Club, Partridge Rd, McNulty Inlet, Cromwell*

6.2 *Racing areas will be in the vicinity of the Lake Dunstan Boat Club.*

7 SCORING

7.1 *The scoring system is as Appendix A of the RRS.*

7.2 *4 races are required to be completed to constitute a series.*

7.3 (a) *When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.*

(b) *When from 5 to 6 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.*

(c) *When 7 or more races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.*

8 LAUNCHING

8.1 *Unless otherwise directed by the Organising Authority, all competing boats and equipment shall be launched and retrieved from McNulty Inlet.*

9 PRIZES

9.1 *To keep the entry fee as low as possible there are no prizes.*

10 DISCLAIMER OF LIABILITY

10.1 *Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.*

11 INSURANCE

Each participating boat should be insured with valid third-party liability insurance with a minimum cover of \$1,000,000 per incident or the equivalent.
